### **Camp Dates and Hours of Operation:**

The 2011 Spring Break Sports Camps will run from Monday, March 26th through Friday, March 30<sup>th</sup>.

Campers may be dropped off at each campsite from 8 a.m. until 9 a.m. each morning. Campers may be picked up between 3 p.m. and 3:45 p.m. each evening. ***Campers must be picked up no later than 4 p.m. -- there will be no staff supervision and facilities will be closed at 4 p.m. Contact Paul Hicks at 580-1764 if you have a legitimate reason for a late pickup. Otherwise, multiple late pickups will result in camper expulsion from the camp program.\****

**What to Bring:**

**Lunch:** Campers will need to bring a lunch, snacks and beverages each day or money to purchase lunch from the club restaurants

**Multi-Sport Camp:** tennis shoes, sunscreen, towel

**Golf Camp:** golf or tennis shoes, sunscreen, towel

**Discipline Issues:**

Campers are expected to follow the instructions of the Camp Coordinator and camp staff.

Campers are never to leave the immediate sports camp area without the express permission of the Camp Coordinator or camp staff.

Disrespect to adult supervisors or to other campers will not be tolerated.

No profanity or abusive language is allowed.

Fighting or physical abuse of adult supervisors or another camper or violation of **any** criminal statute will result in **immediate** expulsion from camp.\*

Discipline issues will be addressed as follows:

**First Incident:** Verbal warning; documented by Camp Coordinator

**Second Incident:** Parent/guardian conference with Camp Coordinator and Athletic Director

**Third Incident:** Expulsion from summer camp program\*

***\* There will be no refund of camp registration fee if camper is terminated from sports camp program due to discipline issues or transportation issues.***

**Proper Attire:**

Modest athletic apparel is to be worn during sports camp sessions. Shirts and shoes must remain on at all times during sports camp sessions.
