SUBJECT: CHARGES RE: AI-23-025

An investigation has been conducted by the Administrative Investigation Division, Professional Standards Bureau, of the Pinellas County Sheriff's Office. As a result of this investigation, the Administrative Review Board has determined that you committed the following violation.

On, but not limited to, October 10, 2023, while on duty in Pinellas County, Florida, you violated the Pinellas County Sheriff's Civil Service Act Laws of Florida, 89-404 as amended by Laws of Florida 08-285, Section 6, Subsection 4, by violating the provisions of law or the rules, regulations, and operating procedures of the Office of the Sheriff.

1. You violated Pinellas County Sheriff's Office General Order 3-1.3, Rule and Regulation 3.31(c), Inappropriate Conduct by Members of the Agency – Careless Handling of Firearms.

Synopsis: On October 10, 2023, you responded to a residence in Pinellas County to take custody of a Savage Model 110 .223 caliber rifle and an Interarms Model 62 .22 caliber rifle, that were being surrendered pursuant to a court order. After collecting the firearms, you unloaded them at the rear of your patrol car and transported them to the North District Station Property and Evidence room. While in the evidence room, you pulled the trigger on the Interarms rifle, accidentally discharging a round of ammunition into the wall.

You acknowledged you were unfamiliar with the firearm, and that you should have contacted an agency armorer for assistance.

During your subject interview, you admitted to this violation.

Disciplinary Points and Recommended Discipline Range:

You were found to be in violation of one (1) Level Three Rules and Regulations violation totaling fifteen (15) points. These points, which were affected by no modified points from previous

discipline, resulted in fifteen (15) progressive discipline points. At this point level, the recommended discipline range is from a Reprimand to a twenty-four (24) hour Suspension.

Disciplinary action shall be consistent with progressive discipline, for cause in accordance with the provisions of the Pinellas County Civil Service Act.
