GENERAL DESCRIPTION

Under the direct supervision of the Crimes Against Children Sergeant, this position combines both direct service to victims of crime and misfortune, and community education, as well as liaison work between the needs of law enforcement and the needs of victims. Work is reviewed through observation and results obtained. **Subject to call-out 24 hours a day, including weekends and holidays as scheduled.**

ESSENTIAL FUNCTIONS AND RESPONSIBILITIES

- Aiding and providing initial counseling for victims of Part I crimes or serious misfortune while referring on to appropriate social services;
- Responding to crime scene, hospital, victim's home or other designated point at the time the crime is reported;
- Provides 24 hour crisis intervention for victims of crime and/or secondary victims;
- Filing for Crimes Compensation for victims in need of financial relief;
- Attending State Attorney investigations, depositions, criminal and civil hearings and trials with victims;
- Conducts training to the Pinellas County Sheriff's Office staff in victim-related areas such as: sexual assault/abuse; child abuse; spouse abuse; homicide survivors, community resources and crime victim compensation;
- Provides limited transport to victims/witnesses to court and various social service agencies;
- Assists staff with making appropriate social service referrals;
- Assists victim in securing the return of any personal property used as evidence when the court procedures are completed;
- Review daily offense reports for appropriate victim advocate case assignment;
- Responding daily to citizen inquiries from external sources such as website, other law enforcement agencies and victim advocate unit main line;
- Makes public presentations on subjects germane to victimology;
- Provides technical assistance to other law enforcement agencies;
- Acts as advocate for the rights of victims on the local, state and national levels;
- Assist with compiling documentation for the CALEA standards and proofs;

QUALIFICATIONS

- Have an open, non-judgmental attitude toward victims, regardless of their circumstances
- Be able to think well and respond quickly in crises
- Exude genuine concern and empathy for victims and their families
- Be able to explain the intricacies of the investigatory and court process
